



## **DAILY VENDOR RULES & REGULATIONS**

1. All Vendors MUST PAY FOR SPACES FIRST before setting up. You can only place merchandise at the space you rented. Only ONE TABLE is provided per space. Do not take tables or move tables from one place to exchange to another. We do not provide a second table. You can bring your own additional table. All merchandise must be contained within the yellow lines of your space. NO merchandise can be hung from any water pipe or electrical conduit. NO merchandise in aisles.
2. This is a RAIN OR SHINE MARKET. No refunds will be given for any reason whatsoever.
3. NO PETS CAN BE BROUGHT IN WITH VENDORS.
4. NO SMOKING UNDER THE ROOF.
5. Please remove ALL YOUR MERCHANDISE, BOXES and, TRASH at the end of the day. Vendors who leave merchandise or trash after vacating a space, will be fined a \$20 clean up charge which must be paid the next time you rent at the market.
6. Post an "ALL SALES FINAL" or similar type of refund policy. If you do not post a refund policy, you are required to remit full cash refunds to customers.
7. All Daily vendors are required to collect and remit 6% sale tax to the Department of Revenue. All Daily Vendors are NOT ALLOWED to sell plants, food or any other items without the required county or state licenses. Vendors MUST present a copy of such licenses to the office prior to renting. Temporary sales tax forms are available at our Office located on B Row.
8. NO SUBLETTING of any spaces whatsoever.
9. All vendors MUST BE FULLY CLOTHED WITH SHIRT AND SHOES at all times. All vendors must conduct their business in a professional manner. No foul language or loud music. If this rule is broken you may be asked to leave the market and possibly be trespassed from the Market.
10. NO VENDORS ARE ALLOWED TO SELL ANY STOLEN MERCHANDISE. If we find you are selling stolen merchandise, we will contact the Sheriff's Department immediately!
11. NO COUNTERFEIT MERCHANDISE ALLOWED.
12. Certain Merchandise lines are 'Closed Out' or allowed only under special circumstances. That is why we always ask what you are selling. You could be asked to remove certain merchandise if it is not allowed and you did not disclose the full content of the merchandise you are selling.
13. All vendors who need electricity MUST bring an extension cord to hook up. We do NOT provide them.
14. NO ALCOHOLIC BEVERAGES can be consumed except those purchased at Beer Stands.
15. NO OVERNIGHT CAMPING OR PARKING ALLOWED.
16. All daily vendors MUST BE GONE no later than 6pm.
17. Daily vendors CANNOT POST SIGNS on the boulevard or elsewhere in the market. No distributions of flyers are allowed. No selling outside your space, off the concrete or out of trailers.
18. THE MARKET RESERVES THE RIGHT TO REFUSE TO RENT TO WHOMEVER WE CHOSE.
